**SECOND AGREED MOTION AND STIPULATED ORDER MODIFYING SCHEDULE
TO FACILITATE SETTLEMENT DISCUSSIONS**

Plaintiff Home Quarters Real Estate Group, Inc. (“HQ”) and Defendants Michigan Data Exchange, Inc., d/b/a MIRealSource (“MIRealSource”) AND Realcomp II Ltd (“Realcomp”), through counsel, stipulate to the following:

1. The parties participated in a settlement conference with Magistrate Judge Morgan on July 29, 2010, pursuant to the Court’s Order of July 1, 2010 [Dkt. #154]. As a result of that conference the parties have made substantial progress toward settlement, and only one final term remains to be resolved before settlement in principal is reached with both Defendants.
2. The parties desire to focus their efforts on settlement and minimize additional attorney fees at this time.
3. Defendants moved to quash deposition subpoenas served by HQ [Dkt# 165], which motion was denied by Magistrate Judge Whalen [Dkt# 180]. An appeal from Magistrate Judge Whalen’s Order is pending before this court. [Dkt. # 172].

4. In addition, HQ presently has pending two motions to amend the complaint to add an additional plaintiff and numerous additional defendants. [Dkt.## 157 and 174].
5. At the request of the parties, the Court entered a Stipulated Order on August 12, 2010 [Dkt. #176] extending until August 20, 2010 the time for: (1) completing the depositions referenced in ¶ 3; and (2) responding to the pending motions and appeal referenced in ¶¶ 3 and 4.
6. The parties agree that settlement discussions will be facilitated by an additional extension of time until August 27, 2010 for:
 - a. Completing the depositions referenced in ¶3;
 - b. Responding to the pending motions and appeal referenced in ¶¶ 3 and 4; and
 - c. Serving HQ's amended damages report.
7. Accordingly, the parties request that this Court enter an Order.
