Plaintiff Regional Multiple Listing Service of Minnesota, Inc., d/b/a NorthstarMLS (“RMLS”), for its Complaint against defendant American Home Realty Network, Inc. (“AHRN”), states and alleges as follows:

NATURE OF THE CASE

1. This is an action for copyright infringement brought under the Copyright Laws of the United States, 17 U.S.C. § 101 *et seq.*

2. Plaintiff RMLS brings this action because defendant AHRN willfully infringed RMLS’s copyrights in the original compilation of its regional multiple listing service database, which it markets as its “NorthstarMLS® Database,” as well as in photographs published on the NorthstarMLS Database, by reproducing, distributing, and displaying these copyrighted works without authorization.

PARTIES

3. Plaintiff RMLS is a corporation organized and existing under the laws of the state of Minnesota, with its principal place of business at 2550 University Avenue West, #259 S, St. Paul, Minnesota 55414.

4. Defendant AHRN is a corporation organized and existing under the laws of the state of Delaware, with its principal place of business at 222 7th Street, 2nd Floor, San Francisco, California, 94103. AHRN is a real estate brokerage that owns and operates the website located at <http://www.neighborcity.com> (the "Neighborcity Website").

JURISDICTION AND VENUE

5. This Court has subject matter jurisdiction over this action pursuant to 28 U.S.C. §§ 1331 and 1338(a), as the claims alleged herein arise under the Copyright Laws of the United States, 17 U.S.C. § 1, *et seq.*

6. This Court has personal jurisdiction over AHRN under Minn. Stat. § 543.19, because AHRN transacts business in Minnesota. On information and belief, AHRN has entered into agreements with Minnesota real estate agents through which AHRN refers prospective real estate buyers to such Minnesota agents. The agents, in turn, pay AHRN for the business referred by AHRN through a portion of the agents' sales commission. Moreover, AHRN has offered to license its various products and services to Minnesota residents. This Court also has personal jurisdiction over AHRN under Minn. Stat. § 543.19, because AHRN has otherwise committed acts in Minnesota causing injury to RMLS in Minnesota. For example, as alleged below, AHRN has reproduced, distributed, and displayed RMLS's copyrighted works on the Neighborcity Website in violation of RMLS's exclusive rights, which has caused injury to RMLS in Minnesota.

7. Venue is proper in this judicial district pursuant to 28 U.S.C. §§ 1391(b) and (c), and 1400(a), because a substantial part of the events alleged herein occurred in Minnesota.

THE COPYRIGHTED WORKS

8. RMLS is a multiple listing service company that serves more than 13,000 real estate brokers and agents in Minnesota and western Wisconsin. As a broker-to-broker cooperative, RMLS facilitates the sale of real property to the benefit of buyers and sellers by providing, among other things, fast and reliable information services and resources to participating brokers and agents.

9. Among the services and systems offered by RMLS is its NorthstarMLS Database, which provides access to tens of thousands of active real estate listings, more than one million comparable and sold properties, and nearly three million property records from numerous Minnesota and Wisconsin counties. Agents and brokerages rely on the NorthstarMLS Database for access to comprehensive real estate listings and other information in their respective markets.

10. RMLS has expended significant time and effort in the creation of its original NorthstarMLS Database. Among the content included in the NorthstarMLS Database are original data fields, descriptors, and content selected, coordinated, and arranged by RMLS.

11. RMLS owns the copyrights relating to the selection, coordination, and arrangement of the fields, descriptors, and content on its NorthstarMLS Database (collectively referred to as the "Compilation Content"). RMLS has registered the copyrights for the Compilation Content with the United States Copyright office on a quarterly basis since at least 1998. The most current certificate of registration for the copyrights in the Compilation Content owned by RMLS is referenced below:

12. RMLS also owns the copyrights in certain photographs accompanying listings for real estate on the NorthstarMLS Database (collectively referred to as the “Photographic Works”). RMLS has registered the copyrights for the Photographic Works with the United States Copyright office. The certificates of registration for the copyrights in the Photographic Works owned by RMLS are referenced below:

13. RMLS has complied with all statutory requirements in securing federal copyright registrations for the copyrights in the Compilation Content and the Photographic Works (such content and works hereinafter collectively referred to as the “Copyrighted Works”). The Copyrighted Works are original works of authorship and constitute copyrightable subject matter under the copyright laws of the United States.

14. The Copyrighted Works have been published on the NorthstarMLS Database, where they can be viewed and downloaded by agents and brokerages licensed by RMLS for

the purpose of further distribution and public display. Each page of the NorthstarMLS Database, as well as each of the Photographic Works, contains a copyright notice indicating that RMLS owns the copyright in both the compilation of the NorthstarMLS Database and the individual Photographic Works.

AHRN'S INFRINGING ACTIVITY

15. As alleged above, AHRN owns and operates the Neighborcity Website, which, according to AHRN, "is a real estate search engine, as well as a Realtor[®] ratings and rankings service that introduces homebuyers and sellers to qualified and vetted local real estate agents who are available to exclusively represent them." The Neighborcity Website also states that AHRN's "real estate search allows you to quickly see where your favorite homes are located and to evaluate the neighborhood from the convenience of your home. Whether you're a buyer, seller, real estate agent or just shopping; NeighborCity brings you the most complete look at your local real estate market."

16. The Neighborcity Website contains copies of the Copyrighted Works that have been reproduced by AHRN in whole or in part and without authorization from RMLS, including the selection, coordination, and arrangement of fields, descriptors, and other content from the Compilation Content as well as Photographic Works. Examples of screen shots revealing AHRN's copying of the selection and arrangement of the fields, descriptors, and content of the NorthstarMLS Database and Photographic Works (with the prominent "NorthstarMLS" copyright notice circled in red) are shown below:

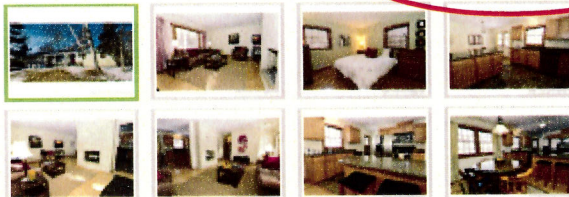

17. AHRN is not now, and never has been, authorized or licensed to reproduce, distribute, or display any of the Copyrighted Works.

18. AHRN has had actual knowledge of the Copyrighted Works and copyright notices since at least November 2011, when RMLS demanded that AHRN cease its unauthorized reproduction, distribution, and display of the Copyrighted Works. Despite this

knowledge, AHRN willfully reproduced, distributed, and/or displayed unauthorized and infringing copies of the Copyrighted Works.

19. On information and belief, AHRN reproduced, distributed, and displayed the Copyrighted Works for the purposes of commercial advantage and/or private financial gain.

FIRST CLAIM FOR RELIEF

(Copyright Infringement of Compilation Content – 17 U.S.C. §§ 101 *et seq.*)

20. RMLS incorporates the allegations contained in paragraphs 1 through 19 above as though fully set forth herein.

21. The Compilation Content consists of original works of authorship and constitute copyrightable subject matter under the copyright laws of the United States. RMLS owns the copyrights in the Compilation Content and has complied with all statutory requirements in securing federal copyright registrations for its Compilation Copyrights. A copy of the most recent certificate of registration for the copyrighted Compilation Content is attached as Exhibit A.

22. AHRN has reproduced, distributed, and/or displayed the Compilation Content, in whole or in part, on AHRN's Neighborcity Website without authorization from RMLS. Such actions by AHRN infringe RMLS's exclusive rights in the copyrights for the Compilation Content in violation of 17 U.S.C. § 501.

23. AHRN's infringing activities have been willful.

24. AHRN has derived profits and has caused RMLS monetary damages as a result of AHRN's infringing conduct.

25. RMLS has suffered irreparable harm as a result of AHRN's infringing activities and will continue to suffer irreparable harm in the future unless AHRN is enjoined from its infringing conduct.

SECOND CLAIM FOR RELIEF

(Copyright Infringement of Photographic Works – 17 U.S.C. §§ 101 *et seq.*)

26. RMLS incorporates the allegations contained in paragraphs 1 through 25 above as though fully set forth herein.

27. The Photographic Works consist of original works of authorship and constitute copyrightable subject matter under the copyright laws of the United States. RMLS owns the copyrights in the Photographic Works and has complied with all statutory requirements in securing federal copyright registrations for the Photographic Works. Copies of the certificates of registration for the copyrighted Photographic Works are attached as Exhibit B.

28. AHRN has reproduced, distributed, and/or displayed the Photographic Works, in whole or in part, on AHRN's Neighborcity Website without authorization from RMLS. Such actions by AHRN infringe RMLS's exclusive rights in the copyrights for the Photographic Works in violation of 17 U.S.C. § 501.

29. AHRN's infringing activities have been willful.

30. AHRN has derived profits and has caused RMLS monetary damages as a result of AHRN's infringing conduct.

31. RMLS has suffered irreparable harm as a result of AHRN's infringing activities and will continue to suffer irreparable harm in the future unless AHRN is enjoined from its infringing conduct.

PRAYER FOR RELIEF

WHEREFORE, RMLS respectfully requests this Court:

- A. Enter judgment that AHRN has willfully infringed the Copyrighted Works;
- B. Enter orders preliminarily and permanently enjoining AHRN and its respective offices, directors, agents, servants, employees and other representatives, as well as those in active concert with them, from infringing any of RMLS's exclusive rights in the Copyrighted Works, including the Compilation Content and the Photographic Works;
- C. Order the impounding for destruction of all unauthorized copies or reproductions of any products containing unauthorized reproductions of the Copyrighted Works, including but not limited to all infringing works displayed on the Neighborcity Website;
- D. Order an accounting of AHRN's profits attributable to AHRN's infringement of the Copyrighted Works;
- E. Award RMLS monetary relief, at the election of RMLS (as authorized by 17 U.S.C. § 504), in an amount to be fixed by the Court in its discretion as just, of either:
 - (1) Actual damages sustained by RMLS as a result of AHRN's infringement of the Copyrighted Works, together with AHRN's profits attributable to the infringement but not taken into account in computing actual damages, pursuant to 17 U.S.C. § 504(b); or
 - (2) statutory damages for each of the Copyrighted Works, as authorized by 17 U.S.C. § 504(c)(2);
- F. Award RMLS's full costs and attorney's fees, as authorized by 17 U.S.C. § 505;

- G. Award RMLS prejudgment and post-judgment interest, as allowed by law; and
- H. Award RMLS such other relief as this Court deems just and appropriate.

REQUEST FOR A JURY TRIAL

Pursuant to Rule 38(b) of the Federal Rules of Civil Procedure, RMLS respectfully requests a trial by jury of any and all issues on which trial by jury is available under applicable law.

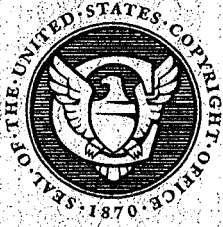

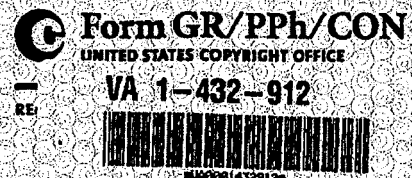

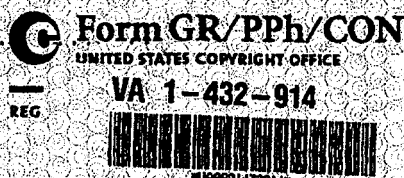
