JOINT STATEMENT
REGARDING TRIAL
READINESS

This Joint Statement responds to the Court’s Order requiring “the parties to file ... a joint statement regarding their readiness for trial and any objections to the court setting this matter for a four-day virtual trial on an available date in the court's schedule in July or August 2021.”

Counsel for the parties have conferred. Both Plaintiff VHT, Inc. and Defendants Zillow Group, Inc., and Zillow, Inc., expect to be ready for trial on any date available to the Court in August 2021. Counsel for both sides have commitments in July 2021 that cannot be rescheduled, which would preclude trial in July 2021. Both sides agree that trial can proceed virtually, and that testimony could be completed and the case sent to the jury within the four days suggested by the Court.

1 VHT would have no objection to proceeding to trial to the Court on the existing record,
2 without presenting additional testimony or documentary evidence. If Zillow continues to
3 demand a jury trial, however, VHT expects to present live testimony at trial.

4 Zillow maintains its demand for a jury trial and expects to present one or more live
5 witnesses in addition to admitting testimony and exhibits from the previous trial as the parties
6 may stipulate or to the extent permitted by the Federal Rules of Evidence.
