STIPULATION AND WAIVER

Respondent.

To the California Department of Insurance:

Respondent, Eugene "Gene" Paul Bleecker, Certificate of Registration Number
OG44891, enters into this Stipulation and Waiver in the above-captioned matter as
follows:

1. Respondent received a copy of the First Amended Accusation ("Accusation"),
Statement to Respondent, and form for Notice of Defense in the above-captioned
matter. Respondent returned a Notice of Defense on January 8, 2020.
2. Respondent wishes to achieve a full and final resolution of the above-captioned
matter in lieu of an evidentiary hearing and decision. Respondent hereby waives
Notice of Hearing and hearing, and all other rights which may be accorded
pursuant to California Government Code §§ 11500-11528, inclusive.

- 1 3. Respondent does not admit the allegations in the Accusation.

- 3 4. As of April 1, 2022, the certificate of registration under which Respondent may
4 market title insurance in the State of California shall be deemed voluntarily
5 surrendered.
- 6
- 7 5. Respondent acknowledges and agrees that, upon surrender of Respondent's
8 certificate of registration, Respondent shall not market, offer, solicit, negotiate, or
9 sell title insurance, as that term is defined in California Insurance Code § 12340.1.
- 10
- 11 6. After the surrender of Respondent's certificate of registration, Respondent shall
12 be permanently barred from applying for or holding any license, registration, or
13 certificate issued by the Insurance Commissioner.
- 14
- 15 7. The terms of this Stipulation and Waiver apply only for the purposes of the above-
16 captioned matter. This Stipulation and Waiver does not settle, waive, release,
17 limit, or prohibit administrative, civil, or criminal investigations and actions against
18 Respondent involving matters alleged in or arising out of the allegations in the
19 Accusation that have been or may be commenced by any entity other than the
20 Department of Insurance. By entering into this Stipulation and Waiver,
21 Respondent does not waive or limit any defense that might otherwise apply in
22 such an investigation or action.

- 25 8. Respondent acknowledges the opportunity to confer with counsel. Respondent
26 freely and voluntarily executes this Stipulation and Waiver, with a full realization of
27 the legal rights set forth in the Statement to Respondent.

1 9. Respondent acknowledges that California Insurance Code § 12921(b)(1)
2 requires the Insurance Commissioner or a delegate to approve the final
3 settlement of this matter. Both the settlement terms and conditions contained
4 herein and the acceptance of those terms and conditions are contingent upon the
5 Commissioner or delegate's approval.

7 Respondent declares the above to be true under penalty of perjury under the
8 laws of the State of California.


